AGC NYS's **Goals and Objectives**


- To further the best interest of the public, the construction industry and the construction client by promoting excellence and high standards of skill, integrity and responsibility;

Governance, Meetings & Committees

AGC NYS is committed to improving the construction industry through its programs and services, and is guided by a Board of Directors that gives guidance and direction toward the association's goals. Statewide and regional membership meetings are held regularly. AGC NYS and AGCA have a host of committees made up of contractors and their associates, focusing on the many issues facing the contractor and the industry.



Government and Legislative Relations

AGC NYS is the voice of the construction industry in New York State. In addition to its two staff lobbyists, AGC NYS employs two Albany-based lobbying firms that monitor over 300 construction-related bills per year. These bills address such issues as: prevailing wage and other labor law matters, bidding, state contracting and other matters covered by the State Finance Law, changes to the Transportation and Vehicle and Traffic Law, environmental issues, and non-budget funding issues. AGC NYS staff conducts Legislative and Executive Branch liaison, to include all contracting and regulatory agencies that provide a market or affect the construction industry. Agency liaisons include OGS, DOT,

Dormitory Authority, Thruway Authority, OSC, SUCF, EDC, Departments of Labor, Law, Tax, Environmental Conservation, Health, Economic Development, and dozens of others. We use our contacts in these government agencies to resolve items of concern, such as late payments, lack of award, specification interpretation, regulatory and jobsite issues. Political contributions to elected officials and candidates are a vital component of our long-term strategy.



Political Action Committee

AGC NYS PAC is used to complement our legislative and funding efforts. PAC contributions help to widen our sphere of influence by targeting legislators that are considered rising stars or future leaders. We forge and cultivate relationships that last beyond just one election cycle.

Funding Efforts

We are in constant contact with the State Legislature, the Governor's office and our Congressional Delegation, advocating for increased investment in our state infrastructure. We routinely engage in public relations campaigns to pressure our lawmakers to find the resources necessary to build and maintain our assets.

Partnering

Since 1988, we have distributed more than \$770,000 in the form of over 370 scholarships to college students working toward a degree in Civil Engineering or Construction Technology at a college or university.

The **Future Construction Leaders** program involves mid-career professionals who have been chosen by their companies as future leaders in the industry.
