HOTEL INFORMATION

EUROPEAN MEAL PLAN - No meals are included in the room rate. There are several on property dining options. Be sure to make a reservation for seating at the restaurants. They are currently operating at 75% capacity.

SERVICE CHARGE - Room rates are subject to 7% NYS sales tax and a 4% county sales tax.

RESORT FEE - There will be a \$40 taxed Resort Fee/per day added to each room that entitles you to two complimentary bottles of water on arrival, wireless internet in guest rooms and public areas, no charge for local and 800 calls, entrance into the Fitness Center, indoor/outdoor pools and waterfront, self or valet parking, Island and Golf Club shuttle. ADDITIONAL GUESTS IN A ROOM CHARGES - For each additional person (over two people) ages 13 & up sharing a room, there will be an additional room charge of \$30.00/person/day.

PAYMENT AND HOTEL CANCELLATION POLICIES - A credit card is required to confirm each reservation. A non-refundable \$35.00 processing fee will be charged at time of booking. The balance of the stay will be charged to this card 14 days prior to the arrival date. PLEASE NOTE: If you reserve your room with a debit card the hotel will charge that card prior to arrival.
